## Superintendent pleased with start of school year

"The schools are ready," Dr. Rhonda Combs said of the first week of school. "They have a warm atmosphere and had fun activities to welcome students back." Braxton's new superintendent is eager to work with Board of Education members and Central Office staff to do whatever needs to be done to improve the education of Braxton County students and to retain all that currently works well.

Coming from a much more urban area in Brooke County, Dr. Combs is adjusting to the different culture of this area. "I do like the small-town atmosphere," she noted when asked to assess what she has seen in the communities and

the schools. "I'm really big on giving kids opportunities. We'll be reaching out to communities and to families. My assumption is that Braxton has a strong community sense. I've already seen a lot of support because people put in volunteer time," she said. Here the superintendent referred to the volunteers who helped after Flatwoods Elementary's building and parking lot suffered flood damage.

The new superintendent realizes that problems exist and is ready to try to solve them. After addressing what she and her staff face in low funding, Dr. Combs explained that she and those with whom she works have begun working on it. "This is a challenge," she said, "but

there are many opportunities for funding, including grants."

Continuing, she noted that she is aware of the negative

effects of the last two years. Asked whether the school system is where it should be, Dr. Combs responded, "There is room for improvement, especially in academics, but we're addressing all of these things. I'm currently working on goals [for the school year and for the school system]. I'm trying to combine my goals with those of the Board members."

To achieve academic improvement, Dr. Combs explained that staff will work as a team to focus on data. "We'll have a lot of focus on that data," she said. There will also be other areas explored to improve the academic level of Braxton County schools and their students.

The superinten-

dent, summarizing her philosophy, said, "I do believe that all students can learn. Some need a lot of support, and some learn at their level. No one size fits all." At this point, Dr. Combs noted, "We need to understand that education is empowerment. Respect for small towns is good, but respect for what's out there is also good. Opportunities for experience allows students to realize their potential and how to get there." She mentioned here that the high school's CTE program has already provided some opportunities for experience.

In closing, Dr. Combs emphasized that her administration is "moving toward more transparency, and she is definitely open to suggestions.

## BoE hears updates on Sheriff DellaMea proposes hiring Chief Deputy

The Braxton Board of Education held a lengthy meeting on August 16. The majority of the meeting was a discussion of the facilities.

Dr. Brenda Wells, Facilities Director, went over the processes involved with facilities management with the new board members and superintendent. She discussed the importance of principals keeping her updated with work request using the SchoolDude program. She also reviewed funding options at the facility level.

Dr. Wells updated the board on the new gym at the middle school. Painting had been completed and work on the floor would begin September 12. The bleachers will be installed upon completion of the floor around September 28. The project should be completed by October 14. Board President Evelyn Post took the opportunity to thank Kelly Pritt for her work painting at the middle school.

Dr. Wells then discussed the issue of flooding at Flatwoods Elementary School. The technician would be running the camera through the culverts on August 17. One of the culverts near the school they know to be an issue already. That culvert is almost two-thirds full of dirt and debris. Dr. Wells, as well as board members, recognized Amanda Gum and her crew of volunteers that worked on getting the playground repaired before school started. The county spent over \$4000 for the pea gravel that the volunteers used to complete the repairs. Larry Hardway noted he had spoken with OES Director John Hoffman with his safety concerns due to the flooding. Hoffman stated that the storm drain near the south entrance of the school was very inadequate. Possible actions to correct the issue included building a wall or redoing the drainage in that area. President Post asked about having the activity buses as an option for

the DOH district supervisor about having a meeting with the stakeholders involved with correcting the issues.

Other projects Dr. Wells discussed were the freezer at the high school, which is scheduled to be shipped mid-September, the replacement of the HVAC systems at the BCHS, and the new roof at the high school.

She also reviewed items that are needed for the facilities including a scissor lift, box truck, CTE van, dump truck with plow, BOE vehicles, and shop truck. Another area with major issues is the bus garage. Those issues have been placed on the bottom of the list as the repairs to buses come first.

She ended her presentation discussing the contract with EMCOR and their preventative maintenance plans.

The first person to speak to the board was Pamela Brown. She voiced her concerns with the boys' soccer team at the high school. Currently only 11 players are on the team which leaves no subs if someone is injured or sick. She also is concerned that the athletes will not have a break during the game as it consists of two straight 40 minute halves with only a 10 minute half-time. Dr. Tony Minney, BCHS Principal, noted that a 12<sup>th</sup> player has joined the team and once the first grading period is complete, a few more boys will be eligible to play. Boys' soccer coach Rick Garavaglia noted that he can play games with as low as seven players and that they were trying to build the program. Coach Garavaglia also voiced concerns over a co-ed team.

Kevin Gregory briefly discussed the formation of different committees that were discussed during the goal setting meeting for the board members to serve on.

President Post asked about having the activity buses as an option for

students. Dr. Wells stated the postings could start for those runs.

Superintendent Dr. Rhonda Combs discussed the numerous professional development trainings that were available to staff over the summer. She briefly talked about the districtwide training through Bowles Rice that went over the mandatory reporting, social media and bullying, and the employee code of conduct.

Dr. Combs noted the General Summative Assessment scores are now public. Director Linda Sears will be doing a presentation to board members at the September 6 meeting and the scores will be going out to students and their parents.

She noted the first day of school was a great first day and the only issue was a tree down across one road that delayed one bus route.

Dr. Combs informed board members that she made a change at the central office. Tim Via will now oversee safety and crisis management as well as his other duties. He will be attending training in October and will work on transitioning everything.

She ended with a brief discussion on covid. Dr. Combs noted she had been contact by the state department on updates with covid

One of the first requests to come before the Braxton County Commission at their regular meeting on Friday, August 19 was from Sheriff Lou DellaMea to fill the position of Chief Deputy. The Sheriff explained that a successful applicant would be responsible for direct supervision of all subordinate Deputy Sheriffs, preparing work schedules and other reports for the Sheriff's approval. He added that the applicant must also be a certified police officer with prior supervision experience.

After hearing the request, Commission President Lisa Godwin told the Sheriff that the Commission would have to reactivate the local Civil Service Board which would have to approve the request before the Commission could take action. Godwin stated that the Commission would move forward with corrective action pertaining to the Civil Service Board. Later in the meeting Lieutenant Bryce Scarboro of the Sheriff's Department stated that he had spoken with the three members previously appointed to the Civil Service Board and all three were willing to continue to serve in that capacity.

Eddie Williams was first to speak to the Board. He gave the Commission an update on the activities of the Pleasant Hill Waterline Association in the area

of fundraising and activities planned for the near future.

Williams also addressed problems at the Falls Run Community Center which is utilized as a polling precinct during elections for that portion of the county. He stated that there was a soft spot in the floor and the porch needed work. He also identified an old concrete walkway that needed to be removed. He requested the county, as they had in the past, provide the labor for the repairs and the Park and Recreation Board would purchase the materials. President Godwin stated that she would have the County Maintenance Department look at the repairs needed.

Beth Atkins introduced Samantha Foster the new librarian at the Sutton Public Library. Foster in turn, reviewed programs that the library was providing and answered questions for the Commission.

The Commission President reviewed the OES/9-1-1 report provided by Director John Hoffman who was not in attendance. That report revealed that Braxton County had fielded 2,757 calls during the month of July with 693 being of an emergency nature. Of those, 561 were referred to the county's law enforcement agencies, 138 were fire related and 175 pertained to the EMS.

On a motion introduced by Larry Clifton, the Commission approved the short form settlements for the following as submitted by the Fiduciary Supervisor: Velma Lynn Clifton, Harold Stephen Gillespie, Linda F. Singleton, Nelva Squires, and John C. Squires.

A motion by Melvin Gum approved the correction of erroneous assessments for: Cynthia Duran, Kortney Davis, Sharon L. Thorne and Foster M Heater, James H. Hall, Lois E. Blake, Lawrence & Anita Wimer, Michael

Rexroad, Charles Lane, Lou Ann Gaines, Robert Coffman, Jacob E. Fairburn Jr., Jesse L & Shirley Teters, Cody A. James, Arthur Boggs Jr., WJ McElwee, Randal Kendall, James W. Belknap, Patrick & Veronica McVay, and Edna Tonkin.

A request to consolidate contiguous tracts of land for tax purposes was approved for Coy J or Jesse Belknap.

Three purchase orders were approved via separate motions: \$10,992 for 8 portable SORN Radios and 12 charges for EMS; Sports Connection, \$1,785 for lettering on 3 Sheriff's cruisers; General Appliance, \$1,919.50 to repair an air handler in the Court room.

The Commission approved a written request from John Hoffman to rehire Ralph A. Marshall as a full-time Emergency Vehicle Operator with extra assigned duties to include ambulance maintenance coordinator and driver training for new hires.

The Commission also approved a request from Hoffman as Mapping Coordinator to name a gravel road off Little Buffalo Road, Eagles Landing Drive.

The Commission approved intragovernmental agreements with the towns of Sutton and Flatwoods for the County to service as Flood Coordinator within the municipalities.

The Commission reviewed the need for small window air conditioning units for the Courthouse Annex while the new unit was being bid and installed. Larry Clifton made a motion to purchase the lowest price which was Wal-Mart for 4-8,000 btu units costing \$2,563.88 and 6-5,000 btu units costing \$2,153.88.

Separate motions approved the county and

A safety hazard...

Not long after I arrived at work on Monday, I received a call from a loyal reader. His message was one of concern. He told me about the special signal at the Frametown Elementary School. We both remember the reason for those lighted signs which resulted some years ago, when a young teacher leaving school was struck by another vehicle and killed.

My caller said he had noticed the sign being down for some time, but was particularly concerned about it now that school was back in session.

After the call, I wasn't sure whether the sign and flashing lights were the responsibility of the Department of Highways or the Educational System. The discussion with my reader lead us both to believe that it was probably the Board of Education. To make sure I called someone I knew could get the bottom of it... Brent Boggs. Brent agreed with our assessment but said he would contact the DOH to make sure.

Later in the day, he called me back and said he had spoken to DOH officials. They had sent a representative to the school and determined that... yes, the sign belonged to school and secondly it was probably damaged beyond repair. He also said the DOH had agreed to place a temporary, non-lighted sign at the school to help take care of the issue while the Board worked on a more permanent fix.

While I was waiting on information from Brent, I emailed Brenda Wells at the Central Office. She promptly answered, saying the Board was aware of the situation and agreed that the sign probably wasn't repairable. She explained that their information indicated that the original damage occurred when a drunk driver hit the signal devise and then left the scene before authorities arrived. She also mentioned that a replacement is estimated to cost around \$20,000.

I can't thank Brent enough for his diligent and speedy work. Hopefully that temporary sign will be in place within a few days and will give the area and school traffic some relief.

I certainly realize that with a new school year and new system leadership Dr. Wells and the entire administration is extremely busy right now. Hopefully today's inquiries and action will put the lights back on track for a permanent solution. I remember the accident that set that project in motion and while any loss of life is too much, that accident, stands out as one of the most tragic in my career of nearly 50 years. I'm sure no one wants a repeat of such a disaster, so while the powers that be, deal with this issue, we all need to remember... school is in session and we need to drive carefully particularly around our school and our precious children!

Every Acre Counts

Appalachin Deer Food Series - Acorns

Last week we discussed several native plants that provide benefits for deer and other wildlife. This week we will finish the short series with a look at acorns or "akerns" as may folks pronounce them.

Acorns are the nut of our native oaks. Much has been written and hundreds of stories told of the great acorn tree deer always go to when the nuts begin hitting the ground. Whitetail Deer fanatics have touted the acorn as a major food source and "the place to be" when

the trees are producing if you are looking to put some meat on the table. So, let's take a look at the acorns and specifically at the two major types of acorns found in central West Virginia – the White Oak and the Red Oak.

Over the past couple of years several studies have looked at how deer use acorns. Many landowners think it is a sin to cut down a white oak tree and have just about as much trouble when it comes to cutting down a red oak. In order to take the myths and legends out of

the article, we will focus on why deer use acorns the way they do.

The Acorn - Why Do Deer Eat Them?

The white oak is probably the king of the acorn kingdom. When white oak acorns are dropping, deer will likely be around to pick them up. Many an article has been written about the deer coming to the should of the thuds as the white oak acorns fall to the ground. The acorns provide the deer with valuable fat for the upcoming rut and winter months and can be an abundant food source at certain times. Writers have often stated – me included – that the tannin in a white oak if less than that of a red oak and hence the deer like them better because they eat them first. How-

ever, recent studies are finding the tannin levels, which make the nut taste bitter, is nearly the same in white oaks and red oaks. So why do deer prefer or seem to prefer white oak acorns over red oak acorns – it may actually be about "time" and not taste.

If we look at the germination time period of the white oak vs. the red oak, we find large differences. When a white oak acorn hits the forest floor, it can germinate and began to grow roots within 2 weeks. Most, if not all white oak acorns, that are good nuts, germinate within 3-4 weeks and therefore are gone or pretty close gone as a food source. Red oaks take months to germinate. Graduate students at Florida State University are working

on an acorn study which is showing similar results to other studies which show deer choose acorns and other food

News from our Capitol

Last week brought some rapidly rising water and localized flooding in areas throughout central West Virginia. I traveled extensively in Braxton and Gilmer Counties last week to check on the scope of the damage. While out, I encountered multiple DOH crews and working to clear storm debris and repair the damage. I appreciate the efforts of our highway maintenance workers and likewise appreciate their response in getting our roadways open after flood-related events.

In recent years, situations are occurring with increasing frequency where there has not been coordination with DOH in placing mismatched and undersized pipes and culverts. It usually works properly for a while, but eventually the flow can get restricted; a blockage forms; and land, business, or residential flooding results. Coupled with the ever-increasing erratic weather patterns,

it's a problem that is costly to correct.

One recent local situation required a special vacuum truck to be brought in from Pennsylvania to clear obstructions from mis-matched drainage pipes impacting Flatwoods Elementary and residents nearby. Hopefully, this will resolve the situation. Meanwhile, I'm recommending to the administration and the DOT that they consider purchasing one or two of these specialized vehicles for use by DOH statewide, when needed. I believe it would be a good investment in protecting property damage and dangers to residents and businesses.

It was great to visit with my friend and former House of Delegates colleague, U.S. Senator Shelly Capito last Tuesday morning during a meeting at Mountaineer Food Bank. Her son, Del. Moore Capito, currently serves in the House with me and it's always great to catch up on family. Moreover, I appreciate her willingness to

listen and act on concerns on the Federal level that impact our citizens here in central West Virginia.

Jean and I spent last Thursday on the road in Glenville and then over to Normantown, Stumptown and on to Rosedale before heading home. It was great to spend time with Glenville Mayor Dennis Fitzpatrick and folks downtown. Also, we stopped by the Gilmer Senior Center to spend some time with Director Sally Mathess, her staff, and many seniors in attendance. guidelines and testing kits for students.

The superintendent also presented the board with two options concerning the position of athletic director. The first was to hire a full-time position posted as assistant principal to the high school and districtwide athletic director. The second option was to increase the supplemental pay for the position as it is currently posted. Both Dr. Combs and Dr. Minney recommended the first option as most beneficial for the schools and to build the programs. Option one was approved on a motion by Larry Hardway with a second by Dr. Kenna Seal.

Under regular business, the board approved the following consent agenda items on a motion by Dr. Kenna Seal with a second by Kevin Gregory: approval of minutes for the July 27 special meeting/work session and the August 2 regular meeting; payment of bills; transportation requests; and budget transfers and supplements.

The following professional, service, and extra-curricular personnel recommendations were also approved on a motion by Larry Hardway with a second by Lisa Ratliff: employment of substitute teachers- John B. Schiefer, Heather Leach-Jones, Shannon Allen, and Rhonda Hunt, Christopher Chance McTaggart, social studies teacher, BCMS, Forrest Taylor, from special education teacher, BCMS to alternative education teacher, BCHS, Virginia Carpenter, from cook, Burnsville to cook, BCMS, Lisa Allen, cook, half-time position, BCHS, Heinrich Harman, special education supervisory/instructional/transportation aide, Nathan Smarr, girls soccer coach, BCHS, and James Huffman and Nathan Short, co-assistent football coaches, BCMS; and resignations for Wesley Monk, elementary music teacher, Randall Brown,

social studies, seventh grade and head boys basketball coach, BCMS, Patrick Facemire, art instructor/world language facilitator, BCMS, Clifton Long, biology, BCHS, Patty Montgomery, substitute teacher, Jeffrey Dennison, substitute bus operator, and Kevin Brown, mechanic/bus operator.

The board approved the fundraisers as presented and the permission to post for interventionist on two separate motions.

The meeting was adjourned at 7:54 pm. The next regular meeting is scheduled for September 6 at 6:00 pm. As always, members of the Braxton County community are encouraged to attend regular board meetings. Anyone wishing to speak as a delegate or with public concerns may do so by signing in up to 15 minutes prior to the start of the meeting.

oak is only available for two to three weeks, the deer are keying on that food source to take advantage of it while it is there. Once gone, they

move to another food source and the initial FSU studies found they came back to red oaks 4-5 months later when that was just about all that remained. When you add in the fact that white oaks don’t produce large mass yields every year, deer know when the white oak acorns hit the ground, they are a limited commodity.

This fact of germination timing is readily evident if you pick up a couple acorns and start your own trees. My Chestnut Oak (Red Oak sub-species) took nearly 4 months in the refrigerator to germinate and the two white oaks I had in the package with them had 6-inch roots by then.

It begs the question, “which oak acorn is more important to the whitetail deer, turkey, bear, etc....?”. Given the fact that red oak acorns are present during the harshest period of the winter, I would argue red oaks. But if you look at your property from a diversity perspective and with a focus of providing food 12 months out the year, not just 4, then you need quality acorn drops from both. White Oaks produce every other year on average and red oaks generally produce annually. If you have both in your woodlot, you have high quality food for your wildlife for 3-4 months to aid in the wildlife making it through the winter in good physical shape.

We will cover the importance of quality trees versus quantity in a later article but having several different varieties of red oak and white oak only adds to the diversity of you property and to the healthy conditions we want to have for our wildlife.

Seniors beware...

Charlie didn’t realize it but once he fell for the fake sweepstakes scam, he became a big target for many similar scams.

He was pleased to be a winner, so he bought seven \$50 gift cards as requested to cover handling costs for his great, but elusive, sweepstakes prize.

Charlie was anxious to make sure he would get the fabulous reward even though he didn’t think he had heard of the sweepstakes before or had any memory of entering.

Charlie had no clue about it, but there is actually a “sucker list” industry that keeps track of scam victims. Criminals sell this information to other criminals because it’s a highly successful pathway for taking people’s money.

How could Charlie be fooled? Scammers find ways to make their victims feel good about the process that’s going on, even when frustrations occur. They also know what to say to eliminate suspicion. It’s happening this very minute to other unsuspecting Charlies and Susies and Annas.

You can avoid being scammed. When any so-called wonderful opportunity includes buying gift cards to assure that everything works out, slam the phone down! Delete that email! The gift cards are the signal that this is a big-time rip-off

scam.

The use of gift cards assures that all your money will disappear. There will be no benefit for you at all, and you won’t be able to get your money back.

For those who believe it’s real, like Charlie did, other scammers will be happy to get your name and contact information. Whether the next one will be a tech support scam or a fake online sweetheart for you (another scam that often involves thousands of dollars lost and real heartache), the whole system is designed to take your money.

The scammer doesn’t care if he or she bleeds you dry. They will just move on to the next victim.

Many don’t realize that a side effect of several medications can decrease a person’s inhibitions. Without realizing it, a person can become less skeptical than before and more prone to taking risks than they would have been without that medication.

The medication and its new behavior can actually lower the barriers to accepting the scam. Yes, taking certain pills can help with medical needs while also making a person more gullible.

Family members and friends need to be aware of this potential side effect.

Also, many victims will do their best to hide that they’ve been scammed. They feel foolish and embarrassed. Many become very good at covering up these situations and keep believing it will work out.

Those who learn of the victim’s situation should remember that being judgmental will likely lead to having the victim shut them off.

Whether we want to believe it or not, any adult of any age can be scammed.

While some feel that they should always answer their phone and never screen their calls, scammers appreciate that attitude.

An answering machine can save you from being the next scam victim. If you are receiving a valid call, that person will leave a message. But most computers from call rooms don’t.

Also, to protect yourself against telemarketers (but probably not scammers), sign up for the National Do Not Call Registry at [donotcall.gov](http://donotcall.gov).

Whether calling from Nigeria, Jamaica or just up the road, the scammers are thieves and know they are hard to catch. Avoiding them takes some effort, but it’s your hard-earned money on the line.

For free help with scams or other legal issues, state residents age 60 or older are encouraged to check with the West Virginia Senior Legal Aid hotline at 800-229-5068. The staff attorney will help you figure out what’s needed to handle the situation.

### Time To Plant Fall Crops

I was talking to my youngest brother, Brent Stewart, recently, and he said he got his turnip seeds planted and he was wishing for rain. I wish we could give them some of our rain. It has rained almost every day. Thunder rumbled all night long in the distance last night and woke us up this morning right over top of the house. Lightning flashed and the rain picked up. Things had settled down and cleared off though by the time we got ready to go to church. The sun even came out later. I did the Drive In Church this morning because the elevator is down and I can't climb all those steep steps to get up into the church. Just tune into 101.9 FM and hear what is going on inside. That sure has come in handy. We had visitors from Ohio today and

there were other visitors there, too.

We saw State Road workers out digging ditches and cleaning up messes from flood waters this past week when we went to Spencer. We saw several trees that had uprooted and had fallen in the road. Those had been cleared out of the way. There were a lot of them. So much rain causes muddy banks and trees uproot and fall. One day this past week, we heard a commotion up at the road and we saw a State Rd. truck hauling a damaged culvert. Hubby said they were probably taking it somewhere to be used for scrap metal. Culverts got clogged up and some were damaged in that recent flood that I wrote about. I saw on FB where some areas got almost three inches of rain. Those that live

up on a hill don't have to worry about flooding. Water drains off but those of us down in a valley get high water. It's a good thing Hubby didn't put in a garden this year. It would have been a lake. Some people are telling me they had to dig their potatoes early because some of them were rotting in the ground. They have to be put somewhere to dry and then put in a potato bin. My parents had a big potato bin in the cellar and it would be clear full and heaped up with potatoes and some white sweet potatoes. I remember the squirrel suppers with mashed potatoes and yellow squirrel gravy. White sweet potatoes and fodder beans, biscuits, squirrel and gravy, applesauce made from the Early Harvest apples, was one of my favorite meals. My Stewart grandparents had an apple orchard and there were enough apples to share with us. We don't eat squirrel anymore, though. Sometimes the taste changes when we get older.

Until next time, enjoy the last of the garden. Some people gather in the last of the crops and grind them up into chow chow, a pickled relish recipe that is good with brown beans, fried potatoes and cornbread in the fall and winter. Take care and God bless!

## 2022 Burnsville Lake, Battle of Bulltown Civil War Reenactment

Mark your calendar for the 2022 Burnsville Lake, Battle Of Bulltown -Civil War Reenactment!

If you are interested in participating in this event as a reenactor or have a reenactment unit, please contact us.

The Battle of Bulltown was a small skirmish fought during the American Civil War near Bulltown in Braxton County, West Virginia on October 13, 1863.

In the fall of 1863, William Lowther Jackson, the cousin of "Stonewall" Jackson, led a raiding party of 800 men into central West Virginia to capture the strategic "fort" at Bulltown which overlooked an important crossing of the Little Kanawha River. The goal was to cut Federal communications between the Greenbrier and Kanawha Valleys.

The Union garrison of roughly 400 men was

commanded by Captain William Mattingly. The Union troops manned a "fort" of makeshift log barricades and shallow trenches which can still be seen today.

Jackson approached Bulltown secretly. He divided his forces in an attempt to converge on the Union position from two different directions. The Confederates advanced at 4:30am on October 13. They quickly captured the Federal pickets but failed to take the main garrison by surprise.

The Confederates advanced against the fort and a drawn-out skirmish lasted until about 4:30pm, almost twelve hours after the battle began. Twice, Jackson sent a flag of truce with a demand to surrender to which Captain Mattingly replied, "I will fight until Hell freezes over and then fight on the ice".

Jackson eventually retreated back towards

the Greenbrier Valley. Casualties were very light considering the length of the battle. On the Union side there were no fatalities. Captain Mattingly was wounded in the thigh and there were some other slight wounds in the Federal camp. The Confederates lost eight killed and a like number wounded.

One civilian, Moses Cunningham, who owned the farm on which the majority of the battle took place, was wounded when he ran out of his house shouting "Hurrah for Jeff Davis."

The battle was the last significant Confederate offensive in West Virginia and the Confederate goals of disrupting the Federal communications were thwarted.





In that match, Kaylee Criner came in at 57, Shawn Toler at 71, and Braeden Shortall at 68.


After explaining that the Stonewall Jackson course "is a very difficult one," Coach Frame discussed the problems his




**Honey** is a five to

Adoption of ownerless cats and kittens came later, as was incorporated with the program because there was no place else for these animals to go. But, due to previously made travel plans and family commitments, Sally Stewart, program director of Just One Generation, will NOT be available to take in new animals or to adopt cats and kittens until after Labor Day.

If you have thoughtfully considered pet ownership, NOW may be the time to add a feline friend to your family. Our program still has several healthy, social cats and kittens that are available for a modest adoption fee.

Our usual adoption fee has been reduced to \$45 each of two for \$70, which includes the spay/neuter/rabies vaccine at Central WV Animal Hospital in Gas-saway when they reach appropriate age.



# THIS WEEK IN WEST VIRGINIA HISTORY




Aug. 24, 1918: Louis Bennett Jr. died of injuries sustained when his plane was shot down by German anti-aircraft fire. Bennett, with 12 combat kills, was West Virginia’s only World War I fighter ace.



August 25, 1903: Soprano Susanne Fisher was born in Sutton. Fisher was the first West Virginian to sing at the Metropolitan Opera.

Aug. 25, 1921: Miners began to arrive at Blair Mountain near the border of Logan and Boone counties. Sheriff Don Chafin, a hated symbol of anti-unionism in southern West Virginia, met them with a combined force of deputies, mine guards, civilian volunteers, and others.



Aug. 25, 2000: The Robert C. Byrd Green Bank Telescope was dedicated. It is the world’s largest fully steerable radio telescope.

Aug. 26, 1863: Union and Confederate forces collided in what became known as the Battle of White Sulphur Springs. The next morning, with ammunition nearly depleted, Union Gen. William Averell decided to retreat to his base without accomplishing any of his objectives.




Aug. 26, 1918: Mathematician Katherine Johnson was born in White Sulphur Springs. For 33 years, Johnson worked for NASA doing calculations for manned space flight, including the Apollo 11 moon landing. In 2015, she received the Presidential Medal of Freedom.



Aug. 27, 1902: Mary McClain was born Mary Smith in Huntington. McClain was a blues legend who performed at Carnegie Hall, the White House, the Apollo Theatre, and the Cotton Club.

Aug. 28, 1900: Harrison H. Ferrell Jr. was born in Chicago. Known as “the Dean” to generations of students, he was professor of German, 1928–66, at West Virginia State College (now University) and served as dean and in other capacities from 1930 until 1970.



Aug. 29, 1952: A groundbreaking ceremony was held in Mercer County to mark the beginning of construction of the West Virginia Turnpike. Initially, most of the turnpike was just two lanes because officials believed revenues would be too low to finance four lanes.

Aug. 30, 1862: Confederate raiders under the command of General Albert G. Jenkins attacked and occupied Buckhannon, where they captured 20 prisoners and 5,000 stands of small arms.
