## Legislative Update

With only days until Christmas, I hope everyone is enjoying the holiday season. While we've not had any meaningful winter weather thus far, I'm sure it's not far away. However, our grandkids are skeptical of our stories of significant snowfall at Thanksgiving and Christ-We had a great mas. weekend with family and friends for my birthday and I'd like to thank everyone that called, emailed, texted or messaged birthday greetings and well-wishes.

I also had a great surprise this afternoon when oldest grandson Collin and one of his buddies traveled up from South Carolina on Sunday to spend a few days with us. Collin loves the farm and I'm sure I'll be spending quite a bit of time at Bonnie this week before he heads back south all too soon.

Last Thursday, was a special day at Braxton County High School as a school assembly was held to honor one of their own, Tyler Baldwin. Recently,

Tyler was credited with saving the life of an elderly neighbor by rescuing him from a burning home. In addition to my representing the House of Delegates and presenting a citation, Fire Chiefs and members of several Braxton County Volunteer Fire Departments, Board of Education President Whipkey, Braxton County Commissioner Gum and representatives of both Senator Manchin and Congressman Moonev were in attendance and for several special presentations. Additionally, a special presentation was made by the WV Fire Marshall Ken Tyree and Deputy Fire Marshall Robert Bailey on behalf of their office and the WV Fire Commission.

Thank you to BCHS Principal Dr. Tony Minney, Superintendent Kathy Hypes and the teachers, staff, and students for planning the program and for taking time to honor Tyler for his heroic and selfless action.

The issue of broadband has been with us nearly as long as I've been in the Legislature. Initially, no

one thought this would be an in-demand service. However, as technology has grown by leaps and bounds, broadband has turned into a must-have for homes and businesses. Ouite simply, the lack of broadband is viewed as a major liability to economic growth and bolstering our declining population and school enrollment in West Virginia. To our credit in Gilmer and Braxton Counties, we were light years ahead of other rural areas of the state, going head-to-head with former landline provider Verizon as we prevailed in setting up a first-ofits-kind non-profit entity (Gilmer-Braxton Technology Research Zone) in conjunction with Glenville State College. While we were successful in some limited wireless deployments, there was not enough available funding at the time to finish the job. If we'd had access to the funds now available, we'd have had nearly all of both counties covered with broadband coverage today.

Now it seems the rest of the State is catching on to what we knew twenty years ago, and I believe in the next year we're going to see the beginnings of getting the dream of broadband out to our citizens in our rural areas. While I recognize that it will not happen everywhere at the same time, I want to ensure that no home or business is lost in the process. That's why I keep in close contact with WV Development Office Secretary Mitch Carmichael. For all practical purposes, the WV Development Office is the manager of the billion dollars available for broadband expansion and the office that will have the most Continued on page 3





Continued from page 2 leverage on where it goes and when.

One problem is that current providers - Frontier in particular - have not provided accurate maps of where broadband is available. In most cases, their information is flawed, indicating a larger coverage area than what is actually the case. In the Joint Committee on Government and Finance a couple of weeks ago during interim meetings, I asked Mitch how citizens that are unserved or underserved can ensure that they are not overlooked due to flawed maps.

He indicated that if you have service, but it is substandard, go on the website of the WV Development Office at: Broadband.wv.gov and take the speed test. This will verify both your location and current upload and download speed.

For those that have no service, call 304-356-0138. This will ensure that if you have no service, your location will be noted by the State Broadband Office. This is extremely



important, as we want no one left behind. If you have any questions, please let me know. Also, spread the word and have everyone in your area take the speed test or call. The better documentation we have in Gilmer and Braxton Counties of our lapses in coverage, the better chance we have of getting service as the first rounds of upgrades and deployments begin early next year.







Learning how to sell something is a skill that has to be honed! We faced an uphill battle in WV trying to sell goat cheese and I totally understand the reluctance of people wanting to even taste goat's milk or cheese. When goat's milk is "goaty", it tastes pretty terrible. "Goaty" is the result of improper handling of the milk.

All equipment, milking buckets, strainers or pipeline milk systems, have to be sterilized before milking. We washed the goats' udders prior to milking with water mixed with hydrogen peroxide, then we dried them with paper towels. Of course, the milkers' hands had to be clean too.

The fat globules in goat's milk are very volatile and if the milk is not cooled down immediately after milking, the globules deteriorate, turn rancid which we interpret as 'goaty".

The French expert on soft goat cheese advised us to use the double boiler method for pasteurizing the milk instead of the faster, new method of forcing the milk through platelets that would again be too harsh on the delicate composition of goat milk. " Goaty" is a fault, an indication of uncleanliness or improper cooling.

We got in touch with Delmer Robinson, the food writer for the Gazette at that time, to ask him for addresses for restaurants that would possibly be interested in using our cheese. It piqued his interest, and he made a trip up to the farm, writing an article in the newspaper. We had the addresses of the top ten restaurants in the state and we started with the Greenbrier.

We did not hear back from them, and it just happened that we had to order more culture from New England Cheese Making and I mentioned to them my slight disappointment. Ricky straightened me out right away.


