Braxton FBLA members qualify for Nationals

Ten members of the local FBLA organization competed at the State Leadership Conference to earn the right to compete at the National Leadership Conference in Chicago June 28-July 2. Students in three events placed first and those in two events placed fourth. All will compete at the national level.

Sarah Dennison, Braxton's FBLA advisor, explained that some of those who competed had taken online tests before the state conference began. Among those were Wyatt Dennison, who placed first in Introduction to Parliamentary Procedure. Dennison competed in an online procedure for his first place and will now compete at the national leadership conference. Another placing first through online testing, Emily Metheny also earned the right to compete nationally. Her topic was Healthcare Administration.

Earning fourth place and the right to compete

nationally were Piper Tonkin and Zoey Moore. Both qualified through online testing. Tonkin's fourth place came in Intro to FBLA. Moore qualified through an online test on Intro to Business Procedure.

A first-place winner involving in-person competition at the State Leadership Conference is composed of Kaylee

Criner, Addison Grindo, and Natalie Rose. These three won first place in Broadcast Journalism, an event which takes careful planning and timing. Kaylee Criner explained the requirements and the group's preparation.

The seven-minute broadcast had to have a

Rotary announces dates for Spring Blood Screening

The Braxton County Rotary Club, in conjunction with WVU Medicine's Braxton County Memorial Hospital has announced the dates for their Spring Blood Screening. The low-cost testing will again be expanded to more than the typical one-day event. The event will follow much the same format as their past two screenings to comply with COVID restrictions and reduce wait times.

Participants can have a basic panel of 35 popular blood tests for the low price of \$35. In addition, several tests can be added for a very nominal price: TSH (Thyroid) \$10, PSA (Men only) \$20, Seasonal Flu Shot \$18, and Hemoglobin A1c \$15. All participants will have to pre-register and be assigned a time to have their blood drawn. This results in extremely short wait times. This year the event will take place on the Wednesday, Thursday and Friday prior to the Saturday, April 23 as well as the same three days following the Saturday event.

Those who find the weekdays more convenient will have their blood drawn at BCHM's old Community Health Center location between the hours of 7:00 and 10:00 AM. Participants may choose from Wednesday, Thursday or Friday, April 20th, 21st and 22nd as well as April 27th, 28th and 29th. The Saturday event will be from 6:30 a.m. to 11:00 p.m. Time slots need to be pre-arranged and are assigned on a first come first serve basis. Participants are reminded that they must complete a registration form to retain the time they select. The weekday events will be held in the building in front of the Hospital's main entrance.

Please follow the signs.

The Saturday event will be held in the former Community Health Center facility in the southern most portion of the BCMH building through the end entrance. Again, please follow the signs.

When patients register, they will be assigned a time and are asked not

Memorial honoring fallen DNR Officer approved for Courthouse square

Lieutenant Tim White of the Department of Natural Resources Law Enforcement Division was one of the first to address the Braxton County Commission at their regular meeting last Friday, March 18. Lt. White said that his professional organization would like to erect a memorial to honor Wesley Frame, a Braxton County native, who was killed in the line of duty in 1978. He stated that his Association would pay for the memorial if the County would allow it to become a permanent part of the Courthouse Square. He further reminded the Commissioners that Officer Frame, a Gassaway High School graduate, was shot and killed while investigating a littering complaint in Monroe County where he was stationed at the time. After hearing the request, Larry Clifton made a motion that the Commission work with Lt. White's organization to design and place a memorial on the Courthouse Square in memory of fallen DNR Officer Wesley Frame.

Addi Facemire, Director of BC Drug Testing Service was first to address the Commission. She presented the body with a report of her agency's activities for the month of February. That report revealed that BC DTS had contacted 93 drug screenings during the month and that 2 individuals had successfully completed the terms of home confinement and were released.

John Cobb and Eddie Williams of the Pleasant Hill Waterline Association made a request that the Commission designate \$315,000 of the county's America Recovery Plan (ARP) funding for engineering and design for their waterline extension. Cobb explained to the Commission

that the funds would allow the project to move up in priority for funding for the project that is estimated to cost between, \$3.9 and \$4.6 million.

"This funding will make our waterline extension 'shovel ready' which according to Region VII will put us in a good place for more Federal and State Funding," Cobb said. Commission President Lisa Godwin suggested that the Commission organize a meeting with all the stakeholders to ensure that everyone was on the same page before the Commission further considered the funding request. The delegation agreed that would be a good idea and ask the Commission to proceed with hosting the meeting.

Kenny Summers, EMS Supervisor, spoke to the Commission regarding the purchase of two new ambulances for the county service. He stated that the best price and delivery timeframe came from Global Emergency Services. He detailed that each ambulance with power cot would cost \$200,681 and take 160 days to deliver. After hearing the presentation and asking questions, Larry Clifton made a motion to proceed with the \$401,363.72 purchase to be paid for with ARP funding.

Sheriff Lou DellaMea and Deputy Bryce Scarboro discussed the purchase of new police cruisers which had been topics at two previous meetings. Scarboro outlined that each of the 3 Ford Explorers would cost \$44,409. Larry Clifton made the motion to approve the purchase using ARP funds.

In other action, the Commission approved the short form settlements as submitted by the Fiduciary Supervisor

for the following: Donald N. Bragg, Tammy Lee Burroughs, Darlene Kay Butcher, Roy Lee Hawkins, Leslie Harold Jackson, E. Mae James, Garnet Paintiff, Alexander Sandy. Jack A. Stalnaker, Shirley Swisher, and Howard Wesley White, Sr.

A single application for correction of erroneous assessments was approved for Judy Cogar.

Melvin Gum introduced separate motions to approve two purchase orders. They authorized the purchase of an IBM Wheelwriter from Around the Office.Com at a cost of \$645 for the County Clerk; The Sheriff will purchase uniforms and equipment to send 2 deputies to the training academy at a cost of \$3,075.32.

Following a brief discussion, Larry Clifton made a motion to transfer the ARP Recovery Funds to the county's general fund to account for lost revenue. The action gives the county more flexibility in how the funds are appropriated.

The Commission approved a list of poll workers for the upcoming May Primary Election as submitted by the County Clerk.

Following a discussion, Larry Clifton made a motion to hire Rachel Davis as a full-time custodian. Davis will be paid \$12.00 per hour with full county benefits.

The Commission approved an internal budget revision from the Prosecuting Attorney.

On separate motions by Melvin Gum, County and EMS invoices were authorized for payment and the minutes of the Commission's March 4 meeting were approved.

Being no further business, the meeting adjourned at 9:49 a.m. The next regular meeting of the Braxton County Commission will be on April 1 beginning at 9:00 a.m.

My name is Kevin Gregory, and I am running for Braxton County Board of Education. I was born and raised near the Braxton/Lewis County line north of Falls Mill, WV. My parents are Nettie and the late Ford Gregory. After attending Burnsville Elementary and Middle School, I graduated from Braxton County High School in

1986. I attended Georgia Military College and graduated in 1988 as a Second Lieutenant, US Army. I completed my B.S. Degree in Criminal Justice in 1990 at Fairmont State University. In November 1990, I began Active Duty at Fort Sill, Oklahoma. Serving as a Field Artillery Officer, I attained the rank of Colonel and retired at 29 years on 30 November 2017. I met my wife, Brenda "Gabby" Gregory, in Oklahoma and we were married in 1992. We have two daughters. Melissa graduated from Fort Knox High School in 2017. Adeline graduated from Braxton County High School in 2019. Both now attend Fairmont State University. In

2021, we finished our "forever home in northern Braxton County just a ½ mile from where I grew up. After 14 different homes, we are happy to be established in West Virginia.

People have asked why I would want to serve on the board and how my military experiences apply to education. The benefits of military service are multifaceted. 1) The military believes in life-long learning; hence, I have a Master of Business Administration and a Master of Arts in Strategic Studies. 2) As an US Army Officer, I have Commanded at every level from Platoon to Brigade, in and out of combat. Between command assignments, the military ensures their leaders are well-rounded, thus much of my experiences are relevant to

planning, budgets, and education. As Fort Sill's Strategic Communications Director, I worked with the Economic Development Planning Commission, the city Mayor, Oklahoma Senator Inhofe, and Representative Coburn as well as many other stakeholders in rebranding and growing the Lawton-Fort Sill area. As a Garrison Commander of Fort Stewart and Hunter Army Airfield near Savannah, GA, my mission required I lead a "city" providing housing, security, education, infrastructure, and training space for 26,000 military members and their families to include the local veteran population. During my tenure as the Fort Stewart/Hunter Army Airfield Commander I served on two Boards of Education representing the military families both on and off base in Liberty County, GA. I also served on the Military Interstate Children's Compact Commission, (MIC3) which functions to set the conditions for military children to transition into and out of school systems without suffering the effects of the varying academic requirements. I completed my career as Chief of Staff, US Army Cadet Command, Fort Knox, KY where my staff of 400+ was responsible for the coordination and resourcing of all the Army ROTC and JROTC programs around the world. Responsible for the curriculum of both the Juvenile and Adult Learning models and to bring the programs up to date in a world with ever-changing environmental conditions and technological advancements. Most importantly, the ROTC mission is to provide an education and training model that will prepare young officers for leading our nation's most valuable resources, our sons and daughters, into the next battle.

News from our Capitol

For the first week after the legislative session, I've slept a little more soundly at night, but the work continues, as the bills that passed and failed are unwound to assess the repercussions, positive and negative. Meanwhile, the Governor has been center stage in the past several days with actions and reactions.

As for Executive actions, the Governor signed the FY 2023 budget bill (SB 250) late last week, but with a heavy red pencil. In using the power of the Governor having budgetary line-item veto authority, Governor Justice eliminated a line in Sec. 9 of the budget document – the general revenue surplus section – by striking out \$265 million set aside by the House Finance Chairman for his state income tax reduction bill that failed to be taken up by the Senate. While House Bill 4007 passed the House, I could not support the bill, as it simply amounted to a tax break for the wealthy, with virtually no benefit to

the average taxpayer. Simply put, 70% of the tax breaks under HB 4007 would have gone to fewer than 20% of the taxpayers had the bill passed.

That's why the way the final budget bill was passed has been under substantial scrutiny from both sides of the political aisle and in the press. The criticism validates my concerns over the recent phenomenon of passing a budget before the session ends, and thereby not full knowledge of what finally passed or failed to pass. The lack of transparency is yet another issue, along with the priorities that cannot provide tax relief for the average working family or retiree despite hanging on to over a billion dollars in projected surplus for "back of the budget" items.

It defies logic to say we have a flat \$4.5 billion general revenue budget, but in fact have another billion in budget spending when the surplus revenue rolls in. Lawmakers on both sides of the aisle are noticing as well as the

public.

Also last week, the Minority leaders in the House and Senate held a press conference to call on the Governor to institute a one-month state motor fuel tax "holiday", thereby cutting gas and diesel prices by over 35 cents per gallon. Governor Justice immediately reacted, referring to the proposal as a political stunt. That was disappointing.

I'm not big on political stunts or grandstanding from either party, because I've always felt stunts, posturing and pandering are not part of good government. However, on this issue at this time, I believe a temporary rollback on the fuel tax is warranted. First, the Governor's own revenue estimates and the budget he signed are projecting a possible \$1 billion revenue surplus. While the motor fuel tax is a fund separate from the general revenue fund, the Legislature has transferred excess general revenue dollars to the road fund multiple times in recent years. Further, a projected \$35 million hit to the road fund could easily be covered out of such a massive projected surplus. The Governor is correct when he states that we have a large, voter approved bond debt from his "Roads to Prosperity" initia-

tive and that the motor fuel tax is what we rely upon to both service the bonds and to build and maintain our roads, bridges and perform highway maintenance. However, I must again refer to having such a large projected surplus to draw from to cover the one-month temporary loss of revenue responsibly and promptly, rendering this argument moot.

A brief, manageable suspension of the state's portion of the gas tax would be a fair and direct way to put dollars immediately back into the pockets of those that need it most. It would help all motorists and proportionately have more benefit to the low- and middle-income taxpayers, yet everyone would receive a benefit.

One important component would be necessary. The WV Attorney General would need to immediately service notice that there would be prompt and meaningful repercussions on any wholesale distributor or retail fuel entity that attempted

Distance learning also kept me from learning in a classroom [with other students]. I learn better hands-on instead of from a computer.”

Zoey Harrison appears to have caught up with most of what she missed as a distance learner her junior year. She is definitely enjoying her senior year and is ready for whatever the future holds.

In addition to those members who placed, Allie White tested in Business Communication, Braylee Robinson, Kaiden Perkins tested in Computer Application, and Emma Rose in Agri Business. Two others who competed but did not attend the State Leadership Conference were Olivia Ramsey and Matthias Garavaglia.

The national conference, Advisor Dennison explained, will include, in addition to new online tests for those going that route and live presentations for the Broadcast Journalism group, an opening ceremony, live presentations by various individuals, and sightseeing. Braxton's advisor noted that Braxton has won very few national awards but she hopes to see some this time.



to raise prices and thereby take advantage of the fuel tax drop for their own profit. If the AG would ensure compliance, our motorists could see an immediate price reduction at the pump of more than \$0.30 per gallon.

While the Governor rejected this proposal, over twenty states are considering the same proposal, with Maryland's republican governor taking this action only a few days ago. Other states have or are in the process of doing likewise. With the emergency powers under COVID that he has yet to rescind, I believe he could do this by executive action. Also, legislators will be back for April interim meetings next month to approve the action.

Meanwhile, no word on what will be done with the \$265 million vetoed by the Governor. Let's hope it's put to good use to benefit areas and citizens of our state most in need.



stations available – one at the 66 Hospital Plaza Heart & Vascular office and the other at the Hospital.

Barker explained that she will coordinate an appointment with the physician for the inpatient. During the appointment, the patient and physician will communicate face-to-face during the consultation. The physician can then control a camera to complete the physical assessment. TeleMon also has stethoscope capability to allow the physician to listen to the lungs and heart.

"This addition to the Clinic and Hospital provides another tool for much-needed cardiac care close to home," said Dr. Sami Aljohani, Cardiologist at the Weston Heart & Vascular office.

pected to win." Everything is not bad, however, as the coach is looking forward to six returning players, including four starters and two bench players.



THIS WEEK IN WEST VIRGINIA HISTORY

The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.



March 23, 2003: Private Jessica Lynch of Palestine, Wirt County, was serving as a supply clerk with the Army's 507th Maintenance Company when she was captured by Iraqi forces after her group was ambushed.

March 24, 1890: Confederate General William Lowther "Mudwall" Jackson died in Louisville. Jackson, who was born in Clarksburg, joined the Confederate Army as a private. After helping to organize an infantry unit, he was promoted to colonel. He served

on the staff of his cousin, Gen. Thomas J. "Stonewall" Jackson, and was jokingly nicknamed "Mudwall."



March 25, 1878: Attorney General Armistead Abraham "Cousin Abe" Lilly was born at Jumping Branch, Summers County. Lilly appealed the Virginia Debt Suit to the U.S. Supreme Court; when settled, it was estimated that Lilly saved the state a large sum of money.

March 26, 1863: The state's first constitution was overwhelmingly ratified by the voters, by a majority of 28,321 to 572. The constitution was drafted during the state's first Constitutional

Canal Treaty.



March 28, 1870: State officials, with state records and property, boarded a steamboat called Mountain Boy, one of six steamboats that moved West Virginia's capital from Wheeling to Charleston.



March 28, 1941: Musician Charlie McCoy was born in Oak Hill. One of the most significant harmonica players in country music, his work can also be heard on rock 'n' roll albums. He was the musical director for the television program Hee Haw.



March 29, 1834: Henry Mason Mathews, the fifth governor of West Virginia, was born at Frankford, Greenbrier County. There were strikes and riots during much of his administration, including the national railroad strike of 1877, which began at Martinsburg.

Eagles begin 2022 baseball season strong with two wins



The Eagles scored strong starts to the season. In the 10-5 win over Clay, Tyler Baldwin

came out to support our club and players. With the proceeds from the bingo, BCSC will be able to continue offering a local scholarship to a graduating Senior and improving the club.



Pierpont Foundation to award more than \$50,000 in scholarships for fall/spring semesters

for our students," said Pierpont Interim President Anthony Hancock. "This support allows our students to achieve an education and secure their future."

Scholarship funds were provided through the Pierpont Foundation, Inc., the nonprofit organization that solicits and administers private donations on behalf of Pierpont Community & Technical College. Nearly \$100,000 in scholarships have been donated or pledged over a three- to five-year period since the Pierpont Foundation began operating independently in

November 2021.

Endowed scholarships are invested, last in perpetuity and can be established with a \$25,000 donation over five years, while non-endowed, named scholarships can be established with a pledge of \$1,000 or more a year for five years. The Pierpont Foundation also accepts one-time scholarship gifts.


